NOTE BY THE DIRECTOR-GENERAL

CALL FOR NOMINATIONS FOR THE SIXTH EXERCISE ON THE ANALYSIS OF BIOTOXINS

- 1. The Director-General wishes to inform OPCW States Parties that the Technical Secretariat (hereinafter "the Secretariat") intends to conduct the sixth exercise on the analysis of samples of biologically derived toxins. The sixth exercise, which will focus on ricin, abrin, and saxitoxin, is scheduled to begin in December 2021.
- 2. The purpose of the exercise is to build expertise in the analysis of samples of toxins listed in the Chemical Weapons Convention (hereinafter "the Convention"), namely ricin and saxitoxin, as well as additional toxins, such as abrin, that are also relevant in cases of alleged use of chemical weapons. The exercise is not intended to be a test of current laboratory proficiency, but rather a means for various laboratories and the Secretariat to examine the specific requirements for toxin identification.
- 3. The exercise will involve a number of samples of biologically derived toxins that participating laboratories will be requested to identify; if possible, the laboratories should also determine the approximate concentrations of the toxin(s). In addition, laboratories may also optionally choose to identify the similarities or differences between the toxin(s) isolated from the samples.
- 4. Approximately one month prior to the dispatch of samples for the exercise, the specific reporting requirements and suggested analytical procedures will be distributed to all nominated laboratories. Laboratories are encouraged to use their own methods of analysis as well as those suggested by the Secretariat and, where possible, to compare the results in their reports. Unlike during OPCW proficiency tests, technical assistance will be available during the exercise, either by telephone or email.
- 5. The results of this exercise will not affect any laboratory currently designated or seeking designation by the OPCW. Participation in this exercise is voluntary and does not replace the requirement of "one OPCW proficiency test per calendar year" required to obtain or retain designated status.
- 6. States Parties are invited to nominate laboratories that are interested in toxin sample analysis or have expertise in that field to participate in this exercise. The exercise is not limited to laboratories that have previously participated in official OPCW proficiency tests.

- 7. The sixth exercise will focus on the detection of ricin, abrin, and saxitoxin, and the OPCW Laboratory will be preparing the samples. The schedule for this exercise is as follows:
 - (a) Samples are expected to be dispatched in early December 2021. The exercise is scheduled so as not to overlap with official OPCW proficiency tests.
 - (b) States Parties should notify the OPCW Laboratory by 19 November 2021 of the nomination of any laboratory wishing to take part in the exercise. The nomination form (attached in the Annex hereto) should be sent via email attachment (biotoxin@opcw.org) and should include the name and address of the laboratory, as well as the name, mailing address, and email address of the contact person at the laboratory. Nominations should also be endorsed by the National Authority of the State Party in which the laboratory is located.
 - (c) Laboratories are requested to submit their analysis reports by 28 February 2022.
- 8. In November 2021, the OPCW Laboratory will provide each nominated laboratory with more details on the nature of the test, potential analytical methods, draft reporting formats, and draft evaluation criteria.
