PURPOSE/INTENT:

A 3-day workshop to share national experiences, explore different approaches and identify best practices of developing legal texts on chemical security reflecting good practices

DATES/VENUE:

19 – 21 July 2022 Bangkok, Thailand

OBJECTIVES:

The Regional Workshop is aimed at providing a forum for discussing:

- 1. The existing legal and regulatory framework related to chemical security of participating States Parties, including --
 - Contextual background on the development of the law/regulation
 - Objectives, scope, thematic area, basic principles/elements covered by the law/regulation
 - How compliance with the requirements under the law is ensured
 - Enforcement methods and penalties for non-compliance
 - The roles of different regulators/implementing agencies
 - How the law/regulation relates to other relevant legal instruments at national level.
- 2. The areas of concern in the chemical life cycle that should be considered in developing chemical security legislation
- 3. National experiences in assessing risks and gaps in existing legal and regulatory regimes as a key basis for determining necessary chemical security measures and for developing or enhancing the existing legal framework on chemical security
- 4. The respective roles of different stakeholders (industry, distributors and others)

PARTICIPANTS:

> States Parties from Asia that consider updating their legal regimes and/or are willing to share their national experiences in developing specific laws/regulations on chemical security

*Each State Party will have three participants: (1) expert on the existing legislative and regulatory framework, (2) industry representative; (3) National Authority focal point

- > States Parties from other regions that have adopted laws/regulations on chemical security and are willing to share their national experiences on the process
 - * Each State Party will have one representative
- > Representatives from international organisations
- > Technical experts

EXPECTED OUTCOMES

- Participants will enhance their understanding of the relationship between implementing legislation on the Chemical Weapons Convention and chemical security legislation.
- Participants are informed about existing international and national legal and regulatory frameworks on chemical security, and will enhance their awareness of the contextual background, objectives, scope, basic principles and key concepts under different national regimes, as well the respective roles of regulators and stakeholders.
- By discussing various national regimes, participants will be able to enhance their understanding of methodologies and approaches for developing a legislative and regulatory framework on chemical security.
- Participants will gain knowledge on risk assessment methodologies and approaches to identify gaps in existing legal regimes, considering respective national contexts and areas of concern in the chemical life cycle that are most relevant in view of the chemicals on the national territory from industry or trade.

BACKGROUND:

The mandate and role of the Organization for the Prohibition of Chemical Weapons (OPCW) in chemical security¹ is grounded in several provisions of the Convention. This role has been elaborated by the policy-making organs of the OPCW in various decisions and reaffirmed during review conferences.²

¹Chemical security refers to measures to prevent deliberate releases of toxic chemicals and to mitigate the impact if such events occur. In a wider context, it also includes policies to prevent attempts to acquire toxic chemicals or chemical weapons precursors, Note by the Technical Secretariat: The Contribution of the OPCW to Chemical Safety and Chemical Security (30 September 2018), S/1129/2013.

² The Second Review Conference "reaffirmed concerns expressed at the First Review Conference that chemical facilities may become subject to attacks or other incidents that could lead to the release or theft of toxic chemicals ... and encouraged States Parties to exchange experiences and discuss related issues" (paragraph 9.94 of RC-2/4, dated 18 April 2008). It also "invited States Parties to consult and cooperate both bilaterally and regionally on ways to prevent terrorists from acquiring and/or using chemical weapons" (paragraph 9.137 of RC-2/4). The Third Review Conference, while recalling States Parties' prime responsibility for chemical security, noted the Secretariat's capacity-building (par 9.126 of RC-3/3, dated 19 April 2013) and coordination role (subparagraph 9.131(k) of RC-3/3), including with regard to chemical facilities and transportation.

In pursuit of this mandate, the Implementation Support Branch (IPB) organized a series of online training courses on legislative and regulatory issues on chemical security across the different regions in 2020 and 2021³. The training courses were organized in response to the growing requests from States Parties for technical assistance in enhancing their knowledge on the legal and regulatory aspects of chemical security and in addressing these issues at the national level. Participants enhanced their understanding of various thematic issues and underscored their continued interest in further capacity-building support from the Technical Secretariat in this area, particularly in drafting chemical security measures appropriate to their respective national contexts or in enhancing their existing legal regimes in order to avert any potential risk of an attack on a chemical facility or the unlawful release or theft of toxic chemicals. The series of training courses also follow on from the Technical Workshop on Sharing of Best Practices in the Development of a Legislative and Regulatory Framework on Chemical Security organized by IPB in July 2019 which provided a forum for sharing information on participating States Parties' legal and regulatory framework on chemical security, as well as discussing approaches in the development of chemical security measures.

During these events, States Parties emphasized the need for further capacity-building support from the Technical Secretariat. States Parties highlighted the importance of developing regulatory measures covering the entire chemical life cycle, and in this regard requested the Technical Secretariat to facilitate information-sharing among States Parties on good practices and national experiences in the process of drafting and adopting legal texts. While some States Parties have adopted and are already implementing laws and regulations on chemical security covering different thematic areas, there is still a dearth of national chemical security measures in place, especially considering the pervasive use and presence of chemicals in countries.

The OPCW, in view of its mandate and its near universal membership, is well-placed to support States Parties in their efforts at enhancing or developing national legal and regulatory frameworks on chemical security.⁴ In response to these requests, IPB plans to organize a series of regional/sub-regional workshops on this theme, beginning with the event for the Asian region in July 2022. Through these forums, participants will be able to enhance their understanding of methodologies and approaches for developing a legislative and regulatory framework on chemical security.
