# NOTE BY THE DIRECTOR-GENERAL

# TRAINING OPPORTUNITY: ASSER INSTITUTE PROGRAMME ON DISARMAMENT AND NON-PROLIFERATION OF WEAPONS OF MASS DESTRUCTION THE HAGUE, THE NETHERLANDS 18 – 22 SEPTEMBER 2023

- 1. On behalf of the Organisation for the Prohibition of Chemical Weapons (OPCW), the Director-General wishes to inform Member States that registration is now open for the Annual Training Programme on Disarmament and Non-Proliferation of Weapons of Mass Destruction, to be held from 18 to 22 September 2023 in The Hague, the Netherlands. This training programme is organised by the Asser Institute for International Law, in collaboration with the OPCW.
- 2. The training programme is designed for early- to mid-career professionals and provides a comprehensive overview of weapons of mass destruction (WMD), striking a balance between the legal, scientific, diplomatic, and geopolitical issues relating to the broad spectrum of WMD in a contemporary world. The training programme will provide clear insights into the functioning of the four international WMD treaty organisations, and illustrate the main challenges each of them currently faces.
- 3. Permanent Representations and their National Authorities are encouraged to promote the training programme among potentially interested groups. It would benefit individuals working for government entities such as national export control bodies, National Authorities for the implementation of the Chemical and Biological Weapons Conventions, and national nuclear (energy) agencies. Professionals working for non-governmental organisations such as think tanks addressing concerns related to WMD and for research centres in related disciplines, as well as newly arrived diplomats in The Hague, are especially encouraged to register.
- 4. Member States are encouraged to consider sponsoring the participation of outstanding national applicants who have demonstrated an interest in disarmament and non-proliferation, and who can be expected to make a significant professional contribution in this area.
- 5. The Dutch Ministry of Foreign Affairs may offer a limited number of scholarships for applicants who are nationals of and working in countries with low- and lower-middle-income economies (according to the World Bank classification<sup>1</sup>). - 6. The specific objectives of the training programme are to provide participants with:
  - (a) hands-on knowledge of the diplomatic, legal, and technical aspects of disarmament and non-proliferation across nuclear, chemical, and biological weapons;
  - (b) insight into the work of seasoned WMD professionals; and
  - (c) unique networking opportunities with speakers and participants from diverse backgrounds.
- 7. The training programme's interdisciplinary content is delivered by specialised academics from institutes in the Netherlands and abroad, together with experienced practitioners and officials from the Biological Weapons Convention Implementation Support Unit, the Preparatory Commission for the Comprehensive Nuclear-Test-Ban Treaty Organization, the International Atomic Energy Agency, and the OPCW. The programme's blend of academic and practical knowledge and its comprehensive scope have been well received by participants and will be continued in 2023.
- 8. The provisional programme is attached as the Annex to this Note.
- 9. The Asser Institute is a non-for-profit, inter-university institute that focuses on the broad field of international law. It is based in The Hague and is partly supported with funding from the Government of the Netherlands. The OPCW collaborates with the Institute in designing the agenda, providing senior staff as speakers, mobilising the participation and support of other WMD-related international organisations, and promoting participation by OPCW stakeholders.
