PUBLIC NOTICE

The requirements to submit Declarations to the National Authority Chemical Weapons Convention (NACWC) are mandated under section 12 of the Chemical Weapons Convention (CWC) Act 2000.

In exercise of extant provisions of CWC Act 2000, it is notified that all the persons and facilities dealing with the chemicals belonging to Schedule 1, Schedule 2 and Schedule 3 categories, including those entities who have filed Annual Declaration of Past Activities (ADPA) for the calendar year 2018 and Annual Declaration of Anticipated Activities (ADAA) for the calendar year 2019, are hereby publically notified to file Annual Declaration of Anticipated Activities (ADAA) for the calendar year 2020 on or before 20th September, 2019.

- The ADAA of 2020 can be filed online using authenticated Digital Signature Certification (DSC) through the URL (http://cwc[dot] nacwc[dot]nic[dot]in) from 1100 Hrs. of 1st September, 2019 and online window will remain open till 20th September, 2019.
- Failure to furnish correct and complete information, with respect to declarations is a punishable offence under the CWC Act 2000.

Annual Declaration of Anticipated Activities (ADAA) for the year 2020-reg.

Sir,

As per the Chemical Weapons Convention, every State Party is obligated, inter alia, to submit to the OPCWC, every year an "Annual Declaration of Anticipated Activities" (ADAA), which shall contain an account of the main activities which the chemical firms situated within its boundaries, propose to undertake during the next calendar year. Towards this purpose, all chemical firms which undertake production, processing, and/or consumption of Schedule 2 chemicals and those which undertake production of Schedule 3 chemical have to submit their individual ADAAs to the respective National Authority. The declaration thresholds set by the convention are as follows;

- a) 1 Kg. of a chemical designated *in Schedule 2, Part A;
- b) 100 Kg of any other chemical listed in Schedule 2, Part A;
- c) 1 Tonne of chemical listed in Schedule 2, Part B; or
- d) >30 tonnes of a Schedule 3 Chemical
- 2. In fulfillment of this obligation and in compliance to relevant provisions of the Chemical Weapons Convention Act of 2000, It is required to submit the ADAA of 2020 before 20th September, 2019. The ADAA of 2020 should be filed online through the URL http://cwc.nacwc.nic.in which will be kept open from 1100 Hrs. of 1st September to 1100 Hrs. to till 20th September, 2019 for this purpose. Online filled declaration with authenticated by Digital signature Certification (DSC) is mandatory in ADAA 2020. Copy of the "Public Notice" published by this Authority in this regard under Section 12 of the Chemical Weapons Convention Act 2000 will be issued in due course.
- I may also remind you that submission of ADAA has to be in proforma prescribed, with complete and accurate information and within the time limit given above. Failure to do so is a criminal offence under the CWC Act.
- 4. Guidelines for filing ADAA online are enclosed. Detailed instruction, prescribed forms, related links etc. will be made available on the NACWC website (www.nacwc.nic.in).
